CANOPY

Pennsylvania's Wilson College, one of our oldest women's colleges (1867), has been known for preparing women for fulfilling and useful living. We have been fortunate to have one of its graduates contributing her talents to our community for over 60 years.

Elizabeth Hudnut Clarkson, known as Nan, an enthusiastic member of Canopy since its beginning, has just celebrated her 90th birthday, and, much to her surprise, Mayor Byron Brown appeared at her

birthday dinner with a proclamation declaring a day in her honor.

She had an early success when her first book was published in 1949, two years after her graduation from Wilson. "You Can Always Tell a Freshman", a book full of stories and advice for college women, illustrated with wonderful cartoons by a classmate and published by E.P. Dutton in New York. It was in print for 18 years and was a classic of its kind. Her last book, "An Adirondack Archive: The Trail to Windover" was published in 1993 and is still in print and selling today. Windover is the name of Nan's family camp in the Adirondacks where their family of three children and six grandchildren gather.

Nan married William M.E. Clarkson (Will) in 1950 and settled in Buffalo. Will worked at Graphic Controls and Nan, while raising their family, took part in serving in the leadership of the International Institute, the Albright (where she was a member of the first Junior Group) and later on the Members Advisory Council of the Albright-Knox, and for 17 years on the Board of the Museum of Science.

In 1990, Mayor Griffin appointed Nan to the Buffalo Arts Commission and soon after she became its chairman.

Trinity Episcopal Church has been Nan's constant and faithful center, where she has served on the vestry. The focus of much of her work and interest in the 60's and 70's was the Civil Rights movement, with some of her writing and much of her work connected with Dr. Lydia C. Wright, who become one of her dearest friends...and for whom Nan worked to have a school named before her death.


So it is understandable that the Urban League's honoring Nan and Will with their Family Life Award in 2007, has special significance for her. She also has an honorary doctorate from her beloved Wilson College and treasures the Arts Award from the National Conference in 1998.

Although she resigned from the Canopy board some time ago after
